Call Meeting to Order: All present.

Approval of Minutes:

➤ Minutes – December 13, 2016 - Monthly Meeting. A motion was made by Mayor Dewey and seconded by Trustee Healy to accept the minutes from the December 13, 2016 monthly meeting as submitted. All in favor – aye. Motion passed.

- A. DPW REPORT
 - ➤ Working Supervisor Bill Lloyd provides written report which was read.
- B. <u>SEWER</u> DEPARTMENT:
 - ➤ Included with DPW report. Regarding the Mennen Road grinder pump wiring, Lloyd stated the wire nut either froze or busted. This wire runs from the grinder pump alarm box to the pump. This should be revisited in the spring as it is the village responsibility to replace the underground wire. We will pull the easement agreement and check location of easement for that property. Lloyd was asked about the list of parts for the repair of the village grinder pumps. Trustee Healy asked if Lloyd had an estimate. Lloyd responded, no, but relays are \$55.00 each, other parts won't be that much and noted there is \$170 remaining from the November approval. Lloyd is to get a quote to the Board for the special meeting held next week.
