Section No. 1. Purpose of Local Law. The purpose of this Local Law is to promote and preserve the health, welfare and property of residents and owners of property located within the Village of Victory, New York, by requiring minors to adhere to a special curfew within the limits of said Village commencing at dark and ending at dawn each year on October 30th and October 31st. This law is being enacted because of the injuries and threats of injuries which have occurred within the Village of Victory each year on October 30th and October 31st.

Section No. 2. Curfew on minors. :It shall be and:it is hereby declared to be unlawful for any minor under the age of eighteen (18) years old to be abroad or on the public streets, lanes, alleys, parks, or any other public places within the Village of Victory, New York, after the time commencing at one half hour before sundown, unless accompanied by the parent or guardian of such minor, or unless the business or employment of such minor, engaged in with the consent of the parent or guardian of such minor, makes it necessary to be upon the streets or other public places in said Village after the hours specified herein. This curfew shall extend until one half hour after sunrise of the following day.

Section No. 3. Special curfew. This curfew shall apply only on the dates of October 30th and October 31st of each year within the Village of Victory. On all other days, Local Law No. 2 of the year 1978 relating to curfew within the Village of Victory, New York, shall apply. As stated above, this special curfew shall extend from one half hour before sunset to one half hour after sunrise each evening on October 30th and October 31st.

Section No. 4. Parent, Guardian or Minor responsible. Any parent or guardian who permits or allows a minor to be abroad upon the streets or other public places in said Village of Victory, New York, or the minor himself who is abroad upon said streets, or other public places in said Village of Victory, New York, contrary to the provisions of Local Law Number 2 of 1978, upon conviction, shall be punished by a fine of not less than Ten and 00/100 (\$10.00) Dollars, nor more than

Fifty and 00/100 (\$50.00) pollars, or by imprisonment for not more than ten:(10) days, or by both such fine and imprisonment.

Section No. 5. Effective date. This Local Law shall take effect immediately following its being filed in the Office of the Secretary of State.
