NOTICE IS HEREBY GIVEN that a public hearing will be held by the Village Board of Trustees of the Village of Victory, Saratoga County, New York at the Village Office in the Village of Victory on the 5th day of June, 1990 at 7:00 P.M., in the matter of a proposed local law entitled "Truck Route System." In general this proposed local law would prohibit vehicles having a gross weight in excess of five (5) tons from streets within the Village of Victory except for deliveries or vehicles with special permits to do so.

NOTICE IS GIVEN FURTHER that at the public hearing above mentioned all interested persons will be heard. A copy of the proposed local law is available for inspection and distribution at the Office of the Village Clerk of the Village of Victory and may be distributed and read by any person interested therein.

VILLAGE OF VICTORY

Local Law No. 1 - 1990

A Local Law relating to a truck route system

Be it enacted by the Village Board of Trustees of the Village of Victory as follows:

SECTION 1. Purpose of Local Law. The purpose of this local law is to promote and preserve the safety, welfare and property of the residents of the Village of Victory, New York, by prohibiting all vehicles, including trucks, tractors; and tractor-trailer combinations, having a gross weight in excess of five (5) tons from travelling and operating on Village streets in the Village of Victory, New York, without a permit to do so.

SECTION 2. Prohibitions. Vehicles having a gross weight in excess of five (5) tons are prohibited in designated locations. The travel and operations of vehicles having a total gross weight in excess of five (5) tons is hereby prohibited from all highways within this Village, except New York State highway known as Route 32, except that this exclusion shall not be construed to prevent the delivery or pickup of merchandise or other property along the highway from which such vehicles and combinations are excluded.

SECTION 3. Permit. Special permits may be issued by the Board of Trustees of the Village of Victory, New York, in order to alleviate any hardships created by the imposition of this Local Law. Said permit shall be good for one (1) year from the date of issue, and the Village Clerk shall charge a fee of Five (\$5.00) Dollars for each one year permit issued. Applications are to be made at the Village Office.

SECTION 4. Violations. Violations shall be dealt with in accordance with Section 1110 (a) of the Vehicle and Traffic Law.

SECTION 5. Penalty. Penalties for traffic infractions shall be imposed in accordance with Section 1800 (b) of the Vehicle and Traffic Law. Any person convicted of a traffic infraction under this Local Law shall, for a first conviction thereof, be punished by a fine of not more than Fifty (\$50.00) Dollars, or by imprisonment for not more than fifteen (15) days, or by both such fine and imprisonment; for a second such conviction within eighteen (18) months thereafter, such person shall be fined for not more than One Hundred (\$100.00) Dollars, or by imprisonment of not more than forty-five (45) days, or by both such fine and imprisonment; upon a third or subsequent conviction within eighteen (18) months after the first conviction, such person shall be punished by a fine of not more than Two Hundred Fifty (\$250.00) Dollars, or by imprisonment for not more than ninety (90) days, or by both such fine and imprisonment.

SECTION 6. SEVERABILITY: In the event that any section, clause or portion of this Local Law shall be held invalid by a court of competent jurisdiction, such holding shall not effect the validity of the remaining sections of this Local Law.

SECTION 7. Effective Date. This Local Law shall be subject to the approval of the New York State Department of Transportation, and shall take effect upon filing of the same in the Office of the Secretary of State.
