VILLAGE OF VICTORY

Local Law No. 1 - 1992

A Local Law relating to Garbage, Rubbish and Refuse

Section 1- Purpose

The purpose of this Local Law is to promote the health, safety, protection and general welfare of the people and property of the Village of Victory through the regulation of garbage, rubbish and refuse disposal and accumulation within the Village and to provide for the enforcement thereof.

Section 2- Definitions

ASHES - The residue of the combustion of any type of solid fuel, such as wood, coal, coke, charcoal or like substance.

GARBAGE - All waste or animal, fish, fowl, fruit or vegetable matter produced from or resulting from the use and storage of food for human consumption.

REFUSE - All discarded, relatively dry, miscellaneous refuse material, including wood, paper, newspaper, rags, excelsior straw, leather, rubber, boxes, sweepings from buildings, tree trimmings, leaves, grass, tin cans, tinware, metal, metallic substances, bottles, glassware, earthenware and other discarded articles of similar nature.

Section 3- Regulations and Restrictions

- A. No person shall throw or scatter or cause to be thrown or scattered or deposited any ashes, refuse or garbage or any other material upon the streets or public places in the Village of Victory.
- B. No person shall deposit or cause to be deposited upon any property within the corporate limits of the Village of Victory any garbage or refuse, and dumping is hereby prohibited, except that ashes may be used to fill in lowland in excavated areas; provided, however, that they shall be immediately covered with at least four (4) inches of dirt. No garbage, refuse or ashes shall be allowed to accumulate upon any proerty within the corporate limits of the Village of Victory so that the same shall become obnoxious, unsightly or offensive.
- C. Nothing contained in this law shall be construed to prohibit any person or householder from the disposing of garbage and refuse in the home by means of household incinerators or other garbage disposal devises, provided that the same produce no smoke or odor and do not become or are not nuisances or hazards.

NOTICE IS HEREBY GIVEN that a public hearing will be held by the Village Board of Trustees of the Village of Victory, Saratoga County, New York at the Village Office in the Village of Victory on the 4th day of February, 1992 at 7:00 P.M., in the matter of a proposed local law entitled "A local law relating to Garbage, Rubbish and Refuse."

In general this proposed local law would provide for the regulation of garbage, rubbish and trash in the Village of Victory.

NOTICE IS GIVEN FURTHER that at the public hearing above mentioned all interested persons will be heard. A copy of the proposed local law is available for inspection and distribution at the Office of the Village Clerk of the Village of Victory and may be distributed and read by any person interested therein.

JEAN NOLAN VILLAGE CLERK VILLAGE OF VICTORY or ashes to collect or remain upon the premises owned or occupied by him so that the same shall become offensive or dangerous to the public health or to any person or property.

- E. No person shall burn garbage or refuse in any manner which causes smoke, odor, flames or other nuisances or health or fire hazards within the corporate limits of the Village of Victory.
- F. Any person allowing garbage, refuse or ashes to accumulate or collect upon his premises, whether as owner, tenant, lessee or occupant, shall be subject to a fine and penalty as hereinafter provided. If the same are not immediately removed and are allowed to remain, each day shall constitute a separate offense and shall subject such owner, lessee or occupant to an additional penalty for each day they so remain.

Section 4- Receptacles

Every owner, lessee, tenant or occupant of any building, premises or place of business in the Village of Victory where garbage or refuse is made or accumulated shall provide or cause to be provided and at all times hereafter shall keep, within such building or upon the premises or place of business, suitable receptacles in accordance with the laws and regulations of the Town of Saratoga and /or the County of Saratoga, as such may be change or modified, for receiving and holding, without leakage, all garbage and refuse that may accumulate from said building, place of business or upon said premises or any portion thereof of which said person may be the owner, tenant, lessee or occupant. Said receptacles shall not be of greater capacity than as receptacles for garbage and refuse and shall be kept in a sanitary condition at all times. Also, rubbish may be securely sacked.

Section 5 - Bulky materials

All garbage, refuse and ashes must be placed in receptacles or containers as herein specified, except for articles and materials too bulky to be so removed. Materials which are too bulky to be placed in containers shall be tied in bundles, and cardboard boxes or wooden crates or collapsible material shall be knocked down and securely tied in flat bundles, not to exceed a size which may be conveniently carried by one (1) man. No wooden containers shall be used for refuse.

Section 6- Penalties

A violation of this local law shall be punishable by a fine not exceeding two hundred fifty dollars (250.00) or by imprisonment not to exceed fifteen (15) days or both.

Section 7- Validity

The invalidity of any such sentence, clause, paragraph or provisions of this local law shall not invalidate any other sentence, caluse, paragraph or provision or part thereof.

Section 8- Effective Date

This local law shall take effect upon the filing of the same in the Office of the Secretary of State.
