A local law Authorizing the Issuance of Appearance Tickets By Public Servants

Be it enacted by the Village Board of Trustees of the

Section 1. The purpose of this local law is to authorize public servants of the Village of Victory to issue and serve appearance tickets in connection with violations of state statutes, local laws, ordinances, or rules and regulations of the Village of Victory which the public servants are authorized or required to enforce.

Section 2. The following public servants of the Village of Victory are hereby authorized to issue and serve an appearance ticket with respect to violations of a state statute, a local law, ordinance, rule or regulations of the Village of Victory that such public servants are, respectively, required or authorized to enforce:

Building Inspector-Building, zoning and planning matters; and all local laws and ordinances of the Village of Victory.

Section 3. An appearance ticket other than for a parking violation shall be served personally.

Section 4. This local law shall take effect immediately upon its filing in the office of the Secretary of State.
