and superceded to the extent of such inconsistency. By way of illustration of the foregoing general statement, but not of limitation thereof:

- (a) Section 4 of this Local Law is intended, and shall be deemed and construed to supercede any contrary provisions contained in Section 3-301 (3) of the New York Village Law;
- (b) Section 5 of this Local Law is intended, and shall be deemed and construed to supercede any contrary provisions contained in Sections 3-308 (5) and 4-400(1)(c) of the New York Village Law;
- (c) Section 6 (a) of this Local Law is intended, and shall be deemed and construed to supercede any contrary provisions contained in Section 7-712 (2) and (11) of the New York Village Law;
- (d) Section 6 (b) of this Local Law is intended, and shall be deemed and construed to supercede any contrary provisions contained in Section 7-718 (1) and (16)(a) of the New York Village Law;
- (e) Section 7 of this Local Law is intended, and shall be deemed and construed to supercede any contrary provisions contained in Section 4-400 (1)(c)(i) and (e) of the New York Village Law;
- (f) Section 8 of this Local Law is intended, and shall be deemed and construed to supercede any contrary provisions contained in Section 4-402 of the New York Village Law;
- (g) Section 9 of this Local Law is intended, and shall be deemed and construed to supercede any contrary provisions contained in Section 4-400, Sections 7-712 (8) and (11)(c), and Sections 7-718 (8) and (16)(c) of the New York Village Law;
 - (h) Section 10 of this Local Law in intended, and shall be deemed and construed to

supercede any contrary provisions contained in Sections 3-308, 3-312 (3) and 4-400 (1)(c) of the New York Village Law and the June 22, 2001 Inter-Municipal Agreement between the Village of Victory and the Village of Schuylerville regarding the establishment and operation of the Victory/Schuylerville Joint Board of Water Management;

- (i) Section 11 of this Local Law is intended, and shall be deemed and construed to supercede any contrary provisions contained in Section 3-312 (3) of the New York Village Law;
- (j) Section 12 of this Local Law is intended, and shall be deemed and construed to supercede any contrary provisions contained in Sections 7-712 (9) and (11)(c), and Sections 7-719 (9) and (16)(c) of the New York Village Law;
- (k) Section 13 of this Local Law is intended, and shall be deemed and construed to supercede any contrary provisions contained in Sections 3-308 and 4-400 of the New York Village Law.
- (l) Section 14 of this Local Law is intended, and shall be deemed and construed to supercede any contrary provisions contained in Section 4-400 (1)(h) of the New York Village Law; and
- (m) Section 15 of this Local Law is intended, and shall be deemed and construed to supercede any contrary provisions contained in Sections 4-400 (1)(a), (b), (d), (e), (f), (g), (h), (i), (j), (k), (l) and (m) of the New York Village Law.
- (n) Section 16 of this Local Law in intended, and shall be deemed and construed to supercede any contrary provision contained in Section 4-400(1)(k) of the New York Village Law.
- (o) Section 17 of this Local Law in intended, and shall be deemed and construed to supercede any contrary provision contained in Section 4-400(1)(I) of the New York Village Law.

- (p) Section 18 of this Local Law in intended, and shall be deemed and construed to supercede any contrary provision contained in Section 4-400(1)(m) of the New York Village Law.
- (q) Section 19 of this Local Law in intended, and shall be deemed and construed to supercede any contrary provision contained in Section 5-500(2) of the New York Village Law.
- (r) Section 20 of this Local Law in intended, and shall be deemed and construed to supercede any contrary provision contained in Section 4-400(1)(a) of the New York Village Law.
- (s) Section 21 of this Local Law in intended, and shall be deemed and construed to supercede any contrary provision contained in Section 4-400(1)(b) of the New York Village Law.
- (t) Section 22 of this Local Law in intended, and shall be deemed and construed to supercede any contrary provision contained in Section 4-400(1)(e) of the New York Village Law.

Section 24. <u>Power To Delegate</u>. Any powers vested in the Board of Trustees pursuant to the provisions of this Local Law may, from time to time, be delegated by the Board of Trustees to one or more elected or appointed officials of the Village of Victory upon such terms and conditions, and for such period or periods of time, as the Board of Trustees may, in its discretion, determine. Such delegation shall be accomplished by a Resolution of the Board of Trustees.

Section 25. Severability.

If any term or provision of this Local Law, or the application thereof to any person or circumstance, shall to any extent be determined by a court of competent jurisdiction to be invalid or unenforceable, the remainder of this Local Law, or the application of such term or provision to persons or circumstances other than those to which it is held invalid or unenforceable, shall not be affected thereby, and each term and provision of this Local Law shall be valid and be enforced to

the fullest extent permitted by law.

Section 26. Mandatory Referendum.

This law is subject to a mandatory referendum, and shall be submitted for approval of the qualified voters of the Village of Victory at a special election not less than sixty (60) days after its adoption by the Board of Trustees in accordance with the provisions of Section 23 of the New York Municipal Home Rule Law. The date of said special election shall be set by resolution of the Board of Trustees.

Section 27. Effective Date.

This local law shall take effect immediately upon adoption and filing with the Secretary of State, after approval by the qualified voters of the Village of Victory, as provided in Sections 23(1) and 27(3) of the Municipal Home Rule Law of the State of New York.
