Local Law No. 2 of the year 1986

A local law Prohibiting Parking in the Entrance to the Village Parking Lot Adjacent to the Post Office.

Be it enacted by the Village Board of Trustees of the Village of Victory as follows:

SECTION 1. TITLE: This Ordinance shall be known as the Parking Ordinance of the Village of Victory, 1986-1.

SECTION 2. LEGISLATIVE INTENT: Due to the traffic congestion at the Village Post Office due to motor vehicles blocking the Village parking lot adjacent thereto and in consideration of the public health, safety and welfare, it is necessary for the Village Board of the Village of Victory to restrict parking in the entrance and exit of said lot in order to facilitate vehicular ingress and egress for said lot.

SECTION 3. PARKING PROHIBITIONS: Parking is prohibited at any time in the 39 foot area between the no parking signs at the entrance to the Village Parking Lot adjacent to the Post Office on the west side of New York State Route 32 in the Village.

SECTION 4. TOW AWAY ZONES: All "no parking areas" shall be and hereby are declared Tow Away Zones. Vehicles illegally parked may be towed. Al towing charges shall be borne solely by the owner or operator of the motor vehicle and shall be in addition to any fines or other penalties.

SECTION 5. VIOLATIONS: Any person violating this ordinance shall be guilty of a violation and shall be subject to a fine not to exceed Fifty (\$50.00) for the first violation; One Hundred

Dollars (\$100.00) for the second violation within six months; Two Hundred Fifty Dollars (\$250.00) within six months for a third violation.

SECTION 6. SEVERABILITY: In the event that any section, clause of portion of this ordinance shall be held invalid by a court of competent jurisdiction, such holding shall not effect

the validity at the remaining sections of this ordinance.

SECTION 7. EFFECTIVE DATE: This ordinance shall take effect ten (10) days from its adoption and publication.
