All reports are read as presented and highlighted as follows:

A. CODE ENFORCEMENT OFFICER REPORT

➤ CEO Larry Wolcott provided a written report which was read. There was a discussion about 70 Gates Avenue having a pool, with no permit issued.

B. DPW/SEWER/WATER DEPARTMENT REPORT

- > Working Supervisor Ryan Campbell provided a written report which was read.
- > There was a discussion regarding the graffiti on the Siege Trail with Mayor Dewey as he was absent from last month's meeting.
- Campbell talked to the Town regarding the mowing and as a result, this should be done. Mayor Dewey noted the entrance off Route 4 has not been mowed yet. Mayor Dewey asked if signs have been reinstalled. There should be three signs and Campbell stated he saw one sign. There was a question on a tent. Campbell said he hasn't seen it.

Various uses of this money could include: Village Hall Thompson Flooring to repair the wood floor, replace carpeting in the office area (price out laminate as an option), ramp/brick wall, overhang (incorporate with ramp awning and mason work) for ramp door.
