Call Meeting to Order

Chairman Corey Helwig called the meeting to order.

Roll Call

Present: Chairman Corey Helwig, Board members Tim Fort and Pete Healy. We also welcome new board members John Nazarenko and Noah Chieco. Also present Secretary Maureen Lewsey.

Announcements:

Chairman Helwig notes that he will not be able to continue his participation as a board member due to the recent village election and the results in becoming Village Mayor starting April 1, 2025. He offers his verbal resignation effective March 31, 2025.

A. 2025 Outline of Saratoga County Planning Board Meeting and Submittal Dates
Secretary Lewsey provided the planning board with the information received from Saratoga County
Planning Board outlining the meeting dates and submittal deadlines, the action referral form and
instructions.

B. Village Planning Board Bylaws to review and Update

Chairman Helwig stated it would be a good idea to review the planning board bylaws and to discuss the procedures as outlined. The timeline for an applicant to get on the agenda was discussed but the applicant has to be ready with all requirements. Chairman Helwig suggested to review sections 1/2/3 to discuss at the April 22, 2025 meeting. He also encouraged the review of the village's comprehensive plan as this will set up the review and potential amendment of the zoning law.

C. Discussion of the Mill Site Project with the Village

Chairman Helwig outlined that Mayor Dewey and the Village Board worked with Empire State Development (ESD) to secure 10 million to remain in the village for addressing the mill site. As Helwig explained the most recent application in February 2020 when the planning board spent 14 months reviewing development plans, declaring a negative declaration, approved the project only to have the epidemic effect Regan Development in pursuing the project.

Currently the mill building is in a state of disrepair. The village is going to take ownership of the 6.6 parcel and provide a 5 million incentive for development. The village will sell either all or a portion of the parcel for development that will once again go through the village planning board for the approval process.

He would like to see a way to honor the original history of the site and the mill but mentioned the village planning board can guide that project. Ideas for the site could include sharing the space with recreation and development. Helwig notes he originally got involved in the planning board because of the mill.

There are steps that have been underway with ESD and discussion of creating a study for strategic planning to determine the best use of the site. The building is on the historic registry and agencies will get involved like SHPO, factors that have been necessary to address.

Ideas of workforce housing with management on site were a plus and he would like the planning board to keep in mind. He had concerns based on what he has seen in a nearby city and the conditions are not those that would work in Victory.

Helwig encouraged the planning board to look at a mixed use of the parcel and to include the Siege Trail and adding to that corridor but also to include some type of business. He also stated the village would utilize a professional consultant in creating the study and offer guidance.

Planning Board member John Nazarenko added the discussion of the viewshed of the Siege Trail by improving this site and allowing access for some type of recreation of the water (Fish Creek). Future improvement could be realized with site redevelopment of the "row houses" in the village.

A general discussion was held on the inclusion of this parcel for tax revenues including utility services. It has a historic aspect with connection to the trails as a plus.

D. Resignation: Chairman Corey Helwig

Chairman Helwig officially states this is his last meeting effective March 31, 2025 as outlined in the announcement section.
