- Patrick Dewey, of Gates Ave, Past Mayor and Budget officer stated the sewer bills were going about 11%-12% down for the residents of Victory.

A. CODE ENFORCEMENT OFFICER REPORT

- CEO Larry Wolcott presented his report to the Board and Public.
 - *Mayor Corey Helwig asked CEO Larry Wolcott when the permit for 23 Herkimer Street will expire. CEO Larry Wolcott stated that it is June, however, he is not sure if it is June 1st or June 30th. CEO Larry Wolcott went on further to state that he will look into the defined date and get back to the board.*

B. DPW/SEWER/WATER DEPARTMENT REPORT

- MEO Logan Steele presented his report to the Board and Public.
- George Lapoint: Rebuild Quotes on Grinder Pumps
 - \$458.00
 - \$1339.25

A Motion was made by Mayor Corey Helwig and Seconded by Trustee Leslie Dennison to approve the repairs in the amount of \$1797.25 for the grinder pumps. All in Favor- Aye.

Mayor Corey Helwig also requested that MEO Logan Steele research training programs to repair the Grinder pumps in house for the future.

- In House Materials Quote for DPW Building at Water Plant for electricity \$689.00.

Mayor Corey Helwig asked MEO Logan Steele and Trustee Dennison if there was ever any approval to connect electricity in the DPW Building at the Water Plant. Trustee Dennison responded that a couple of years ago the Water Department approved the electricity to be installed at the water plant. Trustee Dennison also went further to request that we look back on the water board minutes to find the motion.

Trustee Tammy Mitchell also went further on this topic to note that the quotes that were given by electrical companies were noticed to being significantly different from the rest. She went on further to discuss that she would like to have Conover come back to the plant to give another bid with certain specifications on what will be needed to install the electricity to the plant.

C. FIRE DEPARTMENT REPORT

- Chief Ryan Campbell presented his reports to the Board and Public.
 - ***Mayor Corey Helwig requested an update on the Radio and the percentage discount that could be afforded to the Fire Department. Chief Ryan Campbell responded that he is still in the process of getting all the quotes together and will have a better-defined answer once he receives the quotes in writing from the vendors. Chief Ryan Campbell went on further to announce that the County may be able to offer a discount of up to 30%-40% through June.***
 - ***Trustee Tammy Mitchell requested that the Chief Campbell provide the Standard Operation Procedures to the Board as soon as possible for review as party of the fire department bylaws.***

- A. Resolution: Authorizing Application for a Housing Improvement Program Grant. Flatley Read: Community Development Block Grant.
 - a. ***Mayor Corey Helwig made a motion and was seconded by Trustee Leslie Dennison to approve the Resolution to authorize the Housing Improvement Program Grant Application. All in favor-Aye***
- B. Resolution: Budget Amendment FY24.25 \$21,926.00
 - a. ***Mayor Corey Helwig made a motion and was seconded by Trustee Leslie Dennison to approve the Resolution to Amend the Budget as presented. All in favor-Aye***
- C. Resolution: Declare Village of Victory Lead Agency on the Mill Site Property Demolition and Remediation Project
 - a. ***Mayor Corey Helwig made a motion and was seconded by Trustee Leslie Dennison to approve the Resolution to have the Village of Victory to become Lead Agency of the Mill Site Property Demolition and Remediation Project. All in favor-Aye***
- D. Discussion: Mill Site Property Demolition and Remediation Committee.
 - a. ***Mayor Corey Helwig stated that he is planning on forming a Mill Site Property Demolition and Remediation Committee. Mayor Corey Helwig went on further to state that he is discussing this option with the Village Attorney and is going to table this discussion for 30 days until he gets a clear understanding on what the Project will consist of and what the responsibilities and term limits are for a said committee.***
- E. Resolutions: Reimbursement to Regan Development on the Land Use Escrow Account \$9,440.23
 - a. ***Mayor Corey Helwig made a motion to approve the resolution to Reimburse Regan Development on the Land Use Escrow Account in the amount of \$9,440.23 and was Seconded by Trustee Tammy Mitchell. All in Favor- Aye.***
- F. Discussion: 2025 Economic Development Grant Application- Due June 2025
 - a. ***Trustee Leslie Dennison made a motion to authorize the signing of the 2025 Economic Development Grant Application for \$10,000.00 that is due in June 2025 and was Seconded by Trustee Tammy Mitchell. All in Favor-Aye.***
 - ***Village Clerk/Treasurer Lewsey stated that she will call the County on the project to confirm it complies with the ESD Grant.***
- G. Approval: April Sewer Billing Report \$58,053.14 April Billing + \$17,933.58 October Billing = \$75,986.72.
 - a. ***Trustee Leslie Dennison made a motion to approve the April Sewer Billing of \$75,986.72 and seconded by Mayor Corey Helwig. All in Favor-Aye.***
- H. Approval: Part Time MEO DPW Position. Authorize the Village to Advertise the position available and provide details on Job Duties, Requirements, and Salary Range.
 - a. ***Mayor Corey Helwig made a motion to authorize the Village Clerk to advertise for a part-time MEO Employee for the Village and was Seconded by Trustee Tammy Mitchell. The***

Board set forth the details of the advertisement. The Ad will include requirements of being 18 years of age or older, Clean Drivers license, 24 hours total per week at \$18.00-\$18.50, and work schedule would be 3- 8 hours days a week. All in Favor-Aye.

Village Resident James Sullivan of 11 Pearn St. voiced his concerns with the street lighting and sidewalks in the Village of Victory. Mr. Sullivan explained that he has noticed that there are several street lights out and many sidewalks that were in need of repair. He went on to further state that he has done some research and notice that LED Street Lights could be a better possibility to remedy non-working street lights.
